I DECLARE

I have been informed that the tandem paraglider activity requires the active collaboration of the passenger, which is essential to ensure that all stages of the flight are conducted in complete safety and without risk to the health of the passenger and pilot. I agree to strictly follow the instructions below, which were explained and illustrated in detail before the flight and before signing the present declaration.

- The take off run must never be interrupted unless specifically ordered by the pilot with a clear command, like for example, "stop". It has been explained that the passenger must never stop running even if that seems instinctive, and even when their feet are off the ground, and it is forbidden to sit down on the seat while their feet can still touch the ground or until the pilot gives this explicit permission. If the pilot orders to stop during the take off run, the passenger must not throw their weight forward, sit down, or bend over. Instead they must quickly reduce speed and keep their centre of gravity backwards (uphill) while trying to remain upright.
- The take off run must always be directed towards the point indicated by the pilot and must never deviate from that point, unless the pilot instructs otherwise with a clear command like, "right" or "left". If there is traction in a direction other than that of the run, the passenger must try to maintain the direction of the most recent instruction from the pilot.
- When landing the pilot's instructions must be strictly obeyed. The pilot has explained and I understand that:
 - **a.** When the pilot orders the passenger, they must leave the seated position by moving their hips into a standing position, as in the take off stage.
 - **b.** Immediately upon ground contact the passenger must take a few running steps slowing progressively and without sitting down.
 - **c.** The passenger must not land with both their feet down together.
 - **d.** If instructed by the pilot, the passenger must remain seated and raise their legs until their feet are level with their eyes. The passenger thus remains seated in this position when landing until they come to a stop.
- I confirm that the pilot conducted a pre-flight briefing during which the use of the equipment was explained and illustrated, including
 all the tasks of the passenger and commands from the pilot that must be obeyed so that the flight can be conducted without risk to the
 passenger and pilot.
- I accept personal responsibility, and free the pilot of all responsibility, for the fact that during take off and landing incidents are possible leading to personal injuries that are not a consequence of errors, inexperience, or lack of skill by the pilot. These include, by way of non-exhaustive example, joint sprains during the take off run, or impact between the passenger and pilot or parts of the equipment, or traumas due to impact with the ground when landing. I accept full responsibility for these, freeing the pilot of all responsibility for any such damage or trauma, which I understand to be implicit to the sport of paragliding and which I accept as a "consented risk".
- I understand that participation in tandem paraglider flight can result in accidents even without any error by the pilot conducting the flight, and that the successful outcome of a flight depends on the active collaboration of the passenger, as provided for in Italian P. Decree 133/2010 (art. 4 par. III).
- I have been informed that participation in tandem paraglider flight is not recommended for individuals in poor health or undergoing pharmaceutical therapy, and it is strictly forbidden for anyone under the influence of alcohol or narcotics. I specifically state that non of the above conditions is applicable to me.
- I declare that, within the limits of my knowledge, there are no specific hazards or abnormal conditions that preclude regular paraglider flight.
- I give my explicit and unconditional consent that the entire flight be filmed using audio-visual means and for the use of such recordings.
- I accept from this moment onwards all responsibility for my person as regards damage to myself and/or to others (and/or things) resulting from my failure to comply with the rules and instructions given to me. I fully agree with the purposes of my specific declarations here in the awareness that they are intended for my safety and that of the pilot, and I understand that

failure to abide by the same can put both myself and the pilot at risk.

The pilot is not responsible for the adequacy of the clothing and footwear of the passenger, who bears full responsibility for the same. The passenger has the right and obligation to request explanations and clarifications in cases of doubt, uncertainty, or ambiguity in the instructions and explanations received.
